MEMBERSHIP & FEES (REGISTRATION FEES DUE BY END OF SEASON / YEAR END PARTY NIGHT)

Members must be at least 18 years of age. Fee is \$_____ per person. Fees are payable in full to Erindale Badminton Club by cash or cheque at time of registration. No email money transfer is available at this time. **Fee is refundable in full if:**

1. The renewing member has not played at all by Oct 1st.
2. Renewing members has a life changing event (permanently move out of town, death of loved one/health issues and any other event that the executive deemed life changing by Dec 31st.
3. There are no other instances where there will be full or partial refund.

New members pay full fee if they join before February 1st and 75% of full fee on or after this date. Membership fee is **NOT TRANSFERABLE**.

Membership fees are based on the rental rates for the current school year and the continued partnership with the Ministry of Tourism and Recreation (the “partnership”), however, the EBC Executive Committee reserves the right to adjust membership fees in the event the partnership is terminated during the ensuing year.

GUESTS (subject to club policy)

Guests, if permitted, must be at least 18 years of age. The guest fee, as determined by board members paid per visit is not refundable. Guests may attend on designated days only. Guests must be invited by a member and signed in by a club executive. Members are responsible for the behavior of their invited guests (see Appropriate Conduct Agreement on next page). The club reserves the right to alter these conditions.

Acknowledgment & Assumption of Risks and Release & Indemnity Agreement
(Please Sign In Front of an Executive Member)

Engaging in physical activity at the Erindale Badminton Club involves various potentially serious risks. In consideration of my participation as a member of Erindale Badminton Club for the current season, I acknowledge and agree to assume the risks incidental to such participation (which risks may include, among other things, eye damage, muscle injuries and broken bones) and, on my own behalf, and on behalf of my heirs, executors and administrators, I hereby release and forever discharge the Released Parties defined below, of and from all liabilities, claims, actions, damages, costs or expenses of any nature whatsoever arising out of or in any way connected with my participation, and further agree to indemnify and hold each of the Released Parties harmless against any and all such liabilities, claims, actions, damages, costs, or expenses including, but not limited to, all legal fees and disbursements. In the event that I choose to participate in any activity organized, sponsored, or commissioned by Erindale Badminton Club, the "Released Parties" are the Erindale Badminton Club along with any and all Executive Members of Erindale Badminton Club.

I understand that this Release and Indemnity Agreement includes any claims based on the negligence, action or inaction of any of the above Released Parties and covers any bodily injury or injuries (including death) and property damage, whether suffered by me, before, during or after such participation. I hereby acknowledge and understand that the Released Parties have recommended to me that I confer with a medical practitioner to confirm whether or not I am healthy enough to partake in the physical activity anticipated through my participation at Erindale Badminton Club. I acknowledge and understand that if I proceed to participate as a member of Erindale Badminton Club without first seeking such medical opinion, I do so at my own risk. In view of the foregoing, I declare that I am physically fit and have the skill level 3 required to participate as a member of Erindale Badminton Club.

I further authorize medical intervention and/or treatment for myself, at my own cost, if the need arises at any time whilst on the physical property of the Erindale Badminton Club. Notwithstanding this authorization for medical intervention and/or treatment, I hereby acknowledge and understand that the Released Parties are not medical professionals nor do the Released Parties employ or have on the physical premises of the Erindale Badminton Club any medical professionals. In view of this, I hereby release and forever discharge the Released Parties of and from all liabilities, claims, actions, damages, costs or expenses of any nature whatsoever arising out of or in any way connected with the failure of the Released Parties to arrange for medical intervention and/or treatment for me.

This Agreement shall be governed by the laws of the Province of Ontario. I certify I am 18 years of age or older.

Appropriate Conduct Agreement

(Please Sign In Front of an Executive Member)

Above all else, the goal of Erindale Badminton Club is to offer a venue where each player, whether they be a current member ("Member") or a registered guest, is afforded an equal opportunity to share in the enjoyment of playing badminton, get exercise and socialize with others. The following rules define Appropriate Conduct, and were created to help achieve this goal:

- If present, players are required to help with standard set-up which includes: set-up of stand poles, attachment of string nets, cranking of basketball nets, and the placement of tables and chairs as instructed by officials of the Erindale Badminton Club.
- Courts are available for play only after the set-up has been completed for all available courts.
- Players must place their name-tags behind the last tag on the game selection wheel.
- The player whose tag is at the head of the wheel picks three (3) other tags from the next nine (9) tags and must pick all four (4) name tags at once.
- Players are prohibited from restricting one another from picking them, or another player.
- When picked, a player may opt-out only if the player is leaving the Erindale Badminton Club for the night.
- After finishing their game, all players are to remove their tags from that area and put them at the end of the selection wheel.
- Players may play singles when others are not waiting to play.
- A player may walk across another court only when play is not in session on that court.
- The last players to use a court (within the last 15 minutes of the evening or when there is no one waiting for a court) must return poles, fold and return net, and if present, crank down the basketball net.
- All players present during the final 15 minutes of play are requested to help put away tables, chairs and any other equipment as instructed by officials of Erindale Badminton Club.
- Players must, at all times, treat all other players and Erindale Badminton Club Executive Members and officials in a courteous and respectful manner.

Members or guests who do not adhere to any one or more of the items denoted in this Appropriate Conduct Agreement ("Agreement") or who show inappropriate conduct will have their membership and guest privileges revoked and fees refunded as per our refund policy. Members and guests hereby agree that what constitutes inappropriate conduct for the purposes of this Agreement shall be in the sole and unfettered discretion of the Erindale Badminton Club, its Executive Members and officials.
